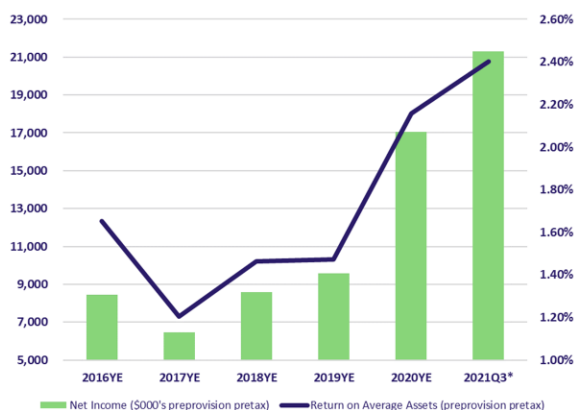


## Managing through the Pandemic

- ❖ Total Originated PPP Loans:
  - ❖ 864 Loans at \$134.5MM
  - ❖ Funded in 2020: \$97.1MM
  - ❖ Funded in 2021: \$37.4MM
  - ❖ Average PPP Loan Balance of ~\$156k
- ❖ PPP Pretax Earnings for 2020 at \$2.4MM and \$2.3MM through Q3 2021
- ❖ As of Q3 2021, \$32.1MM in PPP Loans Remain Outstanding (First & Second Draw Combined)
- ❖ Since the onset of the COVID pandemic, the Bank processed Credit Relief requests for 148 loans totaling \$206.7MM.
  - ❖ As of Q3 2021, all deferred loans are now current and customers are paying on those loans as agreed with the exception of one which is still on principal and interest deferral.
  - ❖ As of Q4 2021, all loans are current.

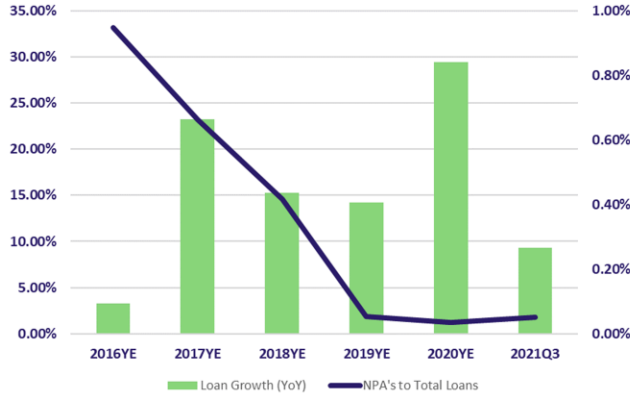

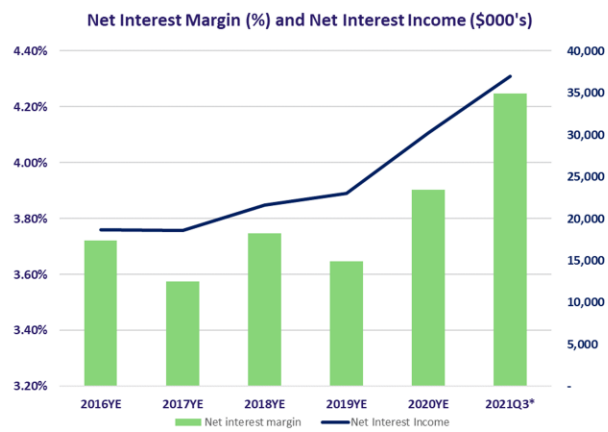

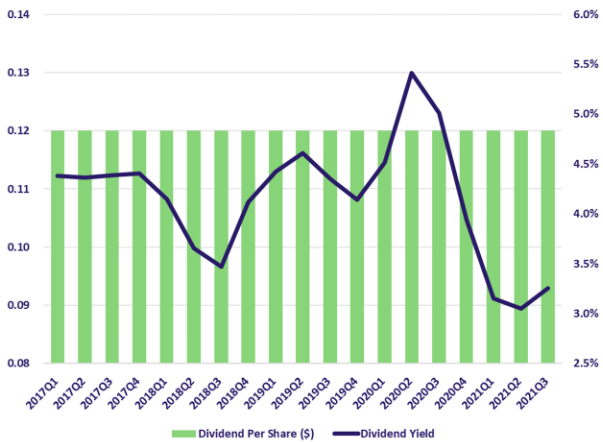

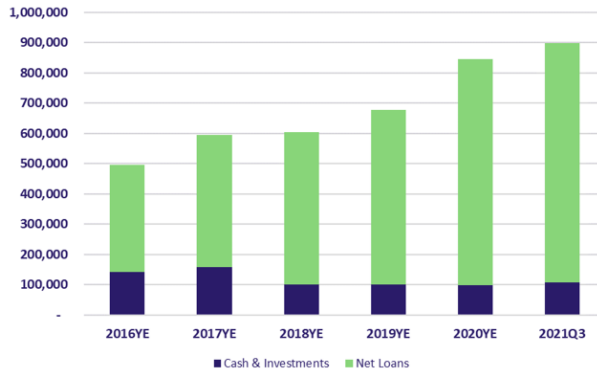

(\$000's)

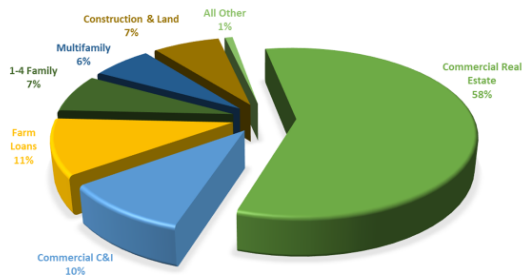

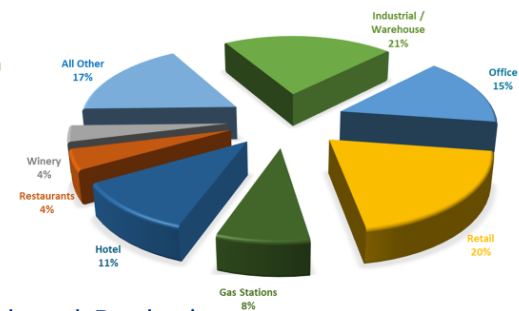

Total Loan Portfolio



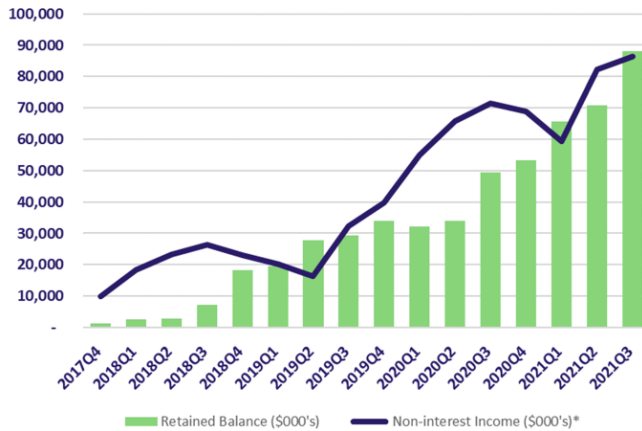
CRE Loan Portfolio Concentration

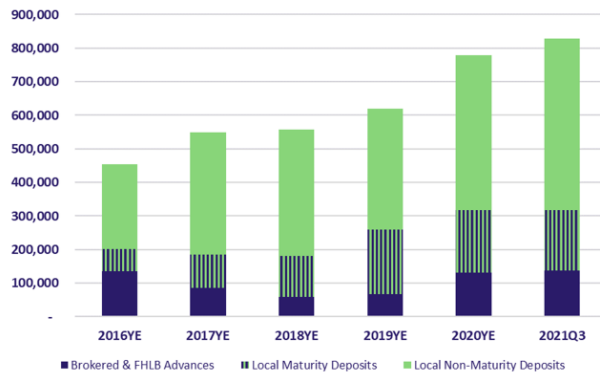

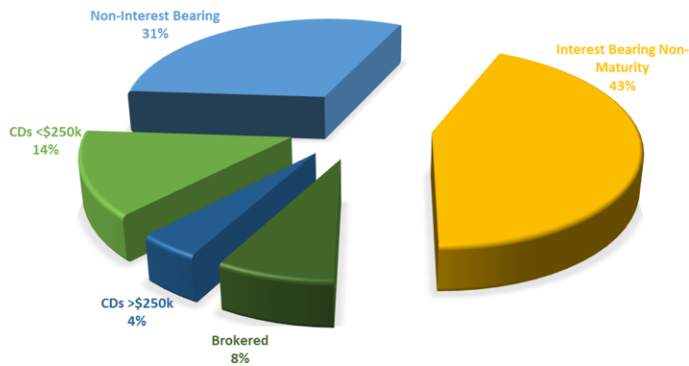
